**WHO:** For those ordered by court, recovery center, attorney, therapist or other for driving under the influence, minor in possession as well as reckless driving, reckless endangerment, deferred prosecution, and negligent driving that is alcohol or other drug-related. *You may bring a guest at no charge. No one under twelve allowed.*

**WHAT:** Creative sentencing for the above.

**WHERE:** Two locations, see below.

**WHEN:** *Times* -- see below. *Dates* -- Freeland: First Sat. of month. / Oak Harbor: varies, check [www.idipic.org](http://www.idipic.org)

**WHY:** You'll know at the end of two hours hopefully.

**HOW MUCH:** \$35 cash or money order. NO COIN. NO PERSONAL CHECKS.

**Directions from North:** Follow Hwy. 20 from Deception Pass Bridge pass about 7 miles. Just past West Gate RV Center you'll see Regatta Drive angles off Hwy 20. Take it 1.2 miles and turn left into driveway.
